<b>WHERE TO APPLY</b>	<ul style="list-style-type: none"> <li>For use in and around buildings and structures including but not limited to houses, apartments, schools, factories, stores, warehouses, hospitals, nursing homes, food processing facilities, restaurants, hotels, motels and zoos.</li> <li>Place bait along ant trails and near ant nests.</li> <li>Place bait in areas not easily accessible to children or pets.</li> </ul>
<b>USE RATE</b>	Place ready-to-use bait as needed.
